

Definition ya consentement affirmatif

Consentement affirmatif eza koyeba, komipesa, mpe koyokana ya batu banso baye basangani pona komi engager na activité sexuelle. Consentement ekoki kopesama na maloba to mpe na ba actions, soki kaka maloba to mpe ba action wana eza kolakisa bopesi nzela pona na oyo etaleli volonté ya ko mi engager na activité sexuelle. Silence to mpe tango mutu aza koresister, yango moko, elakisi consentement te. Definition ya consentement evariyaka te na base ya sex ya participant, orientation sexuelle, identité ya genre, to mpe expression ya genre.

Consentement na acte sexuelle to mpe activité sexuelle oyo esalemaki na consentement na bileko bileki na mutu songolo elingi mpeza koloba te ete consentement esi epesami mpo act sexuelle mususu.

Consentement esengeli epesama ata soki mtu oyo azakosenga acte yango aza na se ya influence ya drogues na/to mpe alcool.

Mutu akoki kopesa Consentement na ngonga songolo mpe retirer yango tango nyoso alingi.

Consentement ekoki kozala te soki mutu oyo asengli kopesa yango aza incapable kolandana na mibeko, oyo ezalaka tango mutu azangi makoki ya kopona ko participer na activité sexuelle. Incapacité ekoki kowuta na bozangi boyebi to mpe kozala yakolala, kozala involontairement recyclé, to mpe soki mutu akoki kopesa consentement te. Kolandana na degree ya intoxication, mutu oyo aza na se ya influence ya alcool, drogue, to mpe ba produit intoxicant misusu, bakoki koconsiderer ye neti incapable mpe nayango akoki kopesa consentement te.

Consentement ekoki kozala considerer te ete epesami soki eza resultat ya tout coercion, intimidation, force, to mpe ya violence.

Tango consentement eza retirer to mpe ekoki te lisusu komipesama, activité sexuelle esengeli esila.

Amnistie kowuta na Acusation ya bosaleli ba Drogue mpe Alcool.

Santé mpe sécurité ya moyekoli nionso na Rockland Community College eza ya litomba. RCCeyebi ete bayekoli oyo bazalaki komela mpe/to kosalela ba drogues (ezala bosaleli bona bozala volontaire to involontaire) na tango ya violence, ezala na violence domestique, violence na masolo ya bolingo, harcèlement, to agression sexuelle esalemi akoki kozala na doute ya kopesa report ya ba incidents mpo na kobanga ba consequences ya conduite na bango. Bayekoli banso baza na droit ya:

Yakosala rapport na ba chief de quartier mpe/ to na police ya engumba;

Kobimisa na polele makambo ya violence domestique, violence na masolo ya bolingo, harcelement mpe agression sexuelle oyo elandelami makasi:

Kozwa decision soki okoki to mpe te kobimisa na polele crime to violation mpe koparticiper na procedure judiciaire to ya conduite morale mpe/to procedure penale oyo aselemi na se ya pression ya institution te;

Koparticiper na procedure oyo yabosolo, oyo eza impartial, mpe kopesa preavis suffisant mpe nzela oyo esengeli mpo ete bayoka yo;

Kozala traité na dignité mpe kozuwa courtoisie kowuta na institution, nabosolo, mpe soin ya santé respectueux na mpe service ya conseil soki esengeli;

Kozala libre na suggestion soki mutu oyo apesi rapport aza na faute tango ba crimes oyo mpe ba violations esalemaki, to soki akokaki koagir na ndenge mususu mpo na koeviter ba crimes to ba violations;

Kodecrire incident na mua ba representant ya ba institution soki esengeli mpe basenga yo lisusu te ozongela description ya incident yango.

Kozala proteger na ba represailles kowuta na institution, moyekoli songolo to pakala, mofundami na/to mofundi, mpe/to baninga, mpe/to libota nabango, mpe ba connaissances nakati ya juridiction ya institution;

Acceder au moins na niveau moko ya appel ya decision;

Kozala accompagner na conseiller ya choix nayo oyo akoki kosalisa mpe kopesa conseil na mutu oyo apesa rapport, mofundami, to mofundi na tango nyoso ya procedure judiciaire to ya conduite morale na ba reunion mpe na audience kolandana na procedure wana;

Exercice droits civile mpe kokota na lingumba ya choix sans batu ya investigation kokotela, justice penale, tope judiciaire tope process ya conduire ya institution.

Droits ezala appliquer sans kotala race, mokobo, nationalité d'origine, religion, lopuso, âge, handicap, sexe, genre ya identité to expression, orientation sexuelle, statut familial, grossesse, caractéristique genetique predisposante, statut militaire, violence domestique, statut ya victime, to condamnation penale mpe independamment na crime to violation ezala esalemaki na campus, libanda ya campus, to tango ozalaki kotanga na mboka mopaya.

Oza na droit ya kosala rapport na Police ya Universite to na Securite ya campus, Police locale mpe/to Police nationale to choisir kosala rapport te; ko pesa rapport ya incident na institution nayo, kozala proteger na institution mpo na ba represailles oyo ekoki koyela yo mpo kaka okopesa rapport ya incident; mpe kozwa assistance na ba ressources kowuta na institution nayo.
