PROGRAM ARTICULATION AGREEMENT

between

Physical Education Teacher Education (PETE) Major, The College at Brockport

and

Rockland Community College

I. INTRODUCTION AND OBJECTIVES

In compliance with the State University of New York's transfer policy the document herewith has been drafted between Rockland Community College and The College at Brockport's Physical Education Teacher Education major. The intent is to facilitate students from Rockland Community College transferring to The College at Brockport and adopting the Physical Education Teacher Education major.

II. TRANSFER TO SUNY COLLEGE AT BROCKPORT

The number of hours to be transferred and the allocation of such hours shall be determined by the following policies:

A. Total Transfer Credit

1. From two-year colleges.

- a. Students holding an approved associate degree from a regionally accredited college may transfer up to 64 credits. Such students will automatically be granted at least 60 credits and junior status. Some students may need more than 60 additional credits to complete the baccalaureate degree requirements depending on previous courses and the major and other academic programs selected at The College at Brockport.
- b. Students without an associate degree from a regionally accredited college may transfer up to 64 credits and be granted junior status.
- 2. From four-year colleges. A total of 90 credits may be accepted for transfer from any regionally accredited four-year college or university.

B. General Education Requirements for Transfer Students.

1. Requirements for students transferring 24 and more credits:

- a. Such students must complete ten of the specified SUNY general education knowledge and skills areas in Basic Communications, Humanities, Social Science, Natural Science, Mathematics, Western Civilization, American history, Foreign Language, Fine Arts, and Other World Civilizations to graduate from The College at Brockport.
- b. Such students must also complete one Perspectives on Women course, a Contemporary Issues course, a Diversity course, and a Computer Skills examination. Transfer credits may be used to fulfill all requirements except the computer exam.

2. Requirements for students transferring fewer than 24 credits.

Such students will be required to meet all Brockport general education requirements for freshman students, which includes all general education requirements listed in 1. above plus an additional Fine Arts and an additional Natural Science course. Transfer credits may be used to fulfill all requirements except the competency examinations.

III. CONSIDERATION FOR TRANSFER TO THE MAJOR PHYSICAL EDUCATION TEACHER EDUCATION (PETE)

To qualify for admission to the PETE major at the College at Brockport, Rockland Community College students must:

- A. Submit a successful application and official transcript to Brockport's Office of Undergraduate Admissions no later than May 1 for fall admission and November 1 for spring admission;
- B. Prior to enrolling in PEP 441 Introduction to Teaching Physical Education, students must have a 2.5 Brockport grade point average for at least 12 credits of work of which no more than 25 percent of the credits are in "activity" classes.
- C. It is recommended that students complete as many of the general education requirements listed in II. B. as possible.
